Pensioner Discount

Pensioners are eligible to receive a 50% reduction in registration fees. Health Care Concession card holders do not qualify for a discounted fee.

Multiple Animals

Only 2 dogs and / or 2 cats may be kept at any urban residence without a Local Laws Permit

Infringement

Failure to register a dog or cat over 3 months of age may incur a \$317 infringement

State Government Levy

The registration fee includes a State Government Levy, which is primarily used to fund responsible pet ownership education programs

Replacement Tags

If your pet has lost or destroyed its registration tag, a new one can be purchased at any Shire office for \$10.00

Privacy Notification

The information provided on this form is subject to Section 18 of the Domestic (Feral and Nuisance) Animal Act 1994 and will be used to update the public animal register as prescribed under the act
