Jenny also presented an idea for the weekend to the committee for two evening events to be held over the weekend. She has been in contact with the Council and has reserved two nights at the Nhill Memorial Centre and shared the idea that perhaps over those two nights, one night could be a free film night and on the other night a concerts / dance and perhaps getting the Piggery Lane Players to perform on the night.
