## Summary of Interests Returns

---

### 1 Background

Section 135 of the *Local Government Act 2020* requires the Chief Executive Officer to publish a summary of personal interests on Council's website following the receipt of personal interests returns. Section 135 requires the following information to be included in the summary of interests:

- the town or suburb, but not the street address or number of the land that is the place of residence of a person as disclosed in the personal interests return; and
- include the matters prescribed by the regulations; and
- exclude the matters required by the regulations to be excluded; and
- be prepared in accordance with the manner prescribed by the regulations.

The *Local Government (Governance and Integrity) Regulations 2020 (Regulations)* also require the following information to be included:

- the name of the specified person;
- all positions held by the specified person as a Councillor, member of a delegated committee, or a member of Council staff;
- the date the specified person lodged the preceding personal interests return;
- a summary of the information disclosed in the specified person's preceding interests return which contains sufficient information to identify the type and nature of the interests disclosed in the return.

The Regulations require the following information to be excluded from the summary of returns:

- the monetary value or amount of the following:
  - income;
  - shares;
  - any beneficial interests other than income or shares;
  - any debt;
- the street address and number of any land owned by the specified person, or in which the specified person has a beneficial interest, if the land is the principal place of residence of any person;
- the information which the specified person has requested in writing not to be included, but only if the CEO considers that including the information would –
  - be reasonably likely to place the personal safety of any person at risk; or
  - unreasonably expose a business, commercial or financial undertaking to disadvantage.
