Hindmarsh Shire Council requires all persons who collect donations for charity or organisations, conduct fundraisers for charities or organisations, or busk within any street, vacant land, land which they do not ordinarily occupy or a public place, to apply for a Street Collectors Permit. A Street Collectors Permit is required to legally collect money or sell items for charitable purposes. This requirement helps ensure transparency, prevents fraud and regulates the number of collections in a specific area. Through the Permit Application process, Council can ensure the collection is appropriate, safe and managed in accordance with Local Laws and other relevant legislation.

What you must do:

Lodge an Application for a Street Collectors Permit with Council. The application must include:

- o A completed *Application Form* (this form)
- A <u>Certificate of Currency</u> of a Public Liability Insurance Policy with a minimum cover of \$20 million. The
 Certificate can be obtained by contacting your insurance provider and must be renewed annually and
 cover all proposed footpath activity. Please note a tax invoice, a schedule of insurance or any other
 similar document is <u>not</u> a Certificate of Currency.
- o Risk Management Plan (as detailed below in the Application Checklist)

Pay the lodgement fee of \$50.00:

A lodgement fee of \$50.00 will be invoiced to the permit applicant at the time the application is registered with Council (usually within one week of lodgement). Payment of the fee is required prior to the issuing/receipt of the Permit.

Note:

Permit holder(s) will be responsible for the currency of their Public Liability Insurance for the duration of the Permit. Failure keep current Public Liability Insurance instantly renders the Permit as invalid. Council may request evidence of your Public Liability Insurance at any time during the Permit period.
